

## Business Referral Incentive Terms and Conditions

1. Vaioni Group Limited has created an incentive proposition under which customers (the “Customer”) are able to claim for a digital amazon voucher (the “Incentive”) in return for referring another business (the “New Business”) to purchase connectivity from Vaioni Group Limited (the “Offer”).
2. The Offer is available in relation to any new connection. For the purpose of these Offer terms, “New Connection” means that the New Business which has been referred does not have an existing connection with Vaioni Group Limited in place.
3. The Offer cannot be exercised by the Customer in conjunction with any other Vaioni Group Limited offer, promotion or discount unless expressly agreed in writing by Vaioni Group Limited.
4. The Customer will be awarded the Incentive via email within 90 working days following the New Business signing the connectivity contract.
5. The Incentive is detailed in the following subpoints;
  - 5.a. £50 Digital amazon voucher awarded to the Customer if the New Business signs a 12 month contract for connectivity with Vaioni Group Limited
  - 5.b. £100 Digital amazon voucher awarded to the Customer if the New Business signs a 36 month contract for connectivity with Vaioni Group Limited
  - 5.c. £150 Digital amazon voucher awarded to the Customer if the New Business signs a 60 month contract for connectivity with Vaioni Group Limited
6. Nothing in this Agreement shall prohibit or affect any claim or demand (whether in contract, tort or otherwise and whether known or unknown to it) in relation to the Original Agreement which the Partner and the Service Provider may have against the other in respect of any matter in relation to the Original Agreement.
7. The New Business will have to meet the below criteria for the Customer to benefit from this incentive
  - 7.a. The New Business must be onboarded and is subject to a credit check, Vaioni Group Limited reserves the right to reject credit to the New Business in its sole discretion upon a credit check.
  - 7.b. The New Business must sign a minimum of a 12 month contract.
  - 7.c. The New Business must commit to a minimum spend of £700 per annum.
  - 7.d. The New Business must sign the connectivity agreement by the offer end date.
8. This offer ends on 31<sup>st</sup> January 2023.
9. The Incentive can be rewarded either to a business or individual.
10. The Customer must provide a valid email address to receive the voucher.
11. Nothing in these Offer terms shall constitute, or be deemed to constitute, a partnership between the parties nor, except as expressly provided, shall it constitute, or be deemed to constitute, any party the agent of any other party for any purpose except as expressly provided.
12. Vaioni Group Limited reserves the right at Vaioni Group Limited’s sole discretion to either (i) withdraw this Offer at any time and without notice; or (ii) terminate the Customer’s right to use the Offer at any time and without notice. Vaioni Group Limited may also refuse any New Business, or exclude such New Order from the Offer, where Vaioni Group Limited considers (in its sole discretion) that the Customer or any New Business does not qualify for the Offer
13. The parties hereby agree that these Offer terms and the provisions herein shall be construed in accordance with the laws of England and they both agree to submit to the exclusive jurisdiction of the English courts in respect of any dispute arising under or in connection with it.
